- (e) military and civilian staff of the armed forces of the sending State,
- (f) members of the clergy and religious societies registered in the Czech Republic,
- (g) foreign nationals when posted to the Czech Republic by their foreign employer on the basis of a contract concluded with a Czech legal or natural person solely for the purpose of increasing skills and qualification needed for their work outside the Czech Republic; or
- (h) persons travelling to the Czech Republic solely for the purpose of a business meeting.

(2) Denmark: However, some special activities are not regarded as paid activity under the national legislation. These persons may enter visa-free under the conditions specifically set out.

(3) Austria: The following special provisions apply to issuing visas for gainful activities: Seasonal and harvest workers have to apply for a visa. The following groups of employees are not considered as carrying out a paid activity and are therefore exempted from the visa requirement under the specified conditions:
